Fire Evacuation Information

Evacuations can be ordered by:

1. Police or fire personnel
2. HPU Administrators, Building Supervisors or their designees, Resident Directors, Resident Assistants, or an HPU Dept. of Public Safety Officer

Evacuation of building:

When the fire alarm sounds or an evacuation order is given:

1. Remain calm
2. Move quickly, in an orderly manner to evacuate the building
3. Do not use elevators
4. Stay with the people from your office or classroom
5. When outside of the building, maintain a distance of at least 100 feet from the building
6. Stay clear of fire lanes and emergency vehicles

Evacuating persons with mobility impairments:

1. Administrators and instructors must assign able-bodied individuals to assist persons with mobility impairments whenever an evacuation is ordered
2. All persons with mobility impairments should be evacuated by way of the closest safe stairway in the campus buildings
3. Notify HPU DPS (325-649-8609) and/or emergency responders if a mobility impaired individual is still in the building due to an inability to get him/her down the stairway

Fire Procedures

It is the responsibility of every employee to know the location of the fire alarm and exit closest to his/her assigned classroom and/or office.

In the event of fire:

1. Pull the nearest fire alarm you can safely access
2. Provide assistance to anyone with a disability for whom building egress may be difficult
3. Proceed calmly to the nearest stairwell
4. Proceed down the stairs (All of the multi-story buildings have stairs; some campus buildings are single story)
5. Move quickly, in an orderly manner to evacuate the building
6. **Do not use elevators**
7. Stay with the people from your office, classroom, or residential unit
8. When outside of the building, maintain a distance of at least 100 feet from the building
9. Stay clear of fire lanes and emergency vehicles
10. Do not re-enter the facility until given the "all clear" by HPU DPS or emergency responders

IF A DOOR FEELS WARM – DO NOT OPEN IT! IF THERE IS HEAVY SMOKE – STAY NEAR THE FLOOR AND BREATHE THROUGH A PIECE OF CLOTHING. DO NOT RUN!

To use a fire extinguisher:

If the fire is small or extremely isolated, you may use a wall-mounted fire extinguisher. Do not use water on any fire. Be sure to notify HPU Facilities (325-649-8607) or HPU DPS (325-649-8609) immediately after discharging a fire extinguisher.

Policies for Portable Electrical Appliances, Smoking, and Open Flames in Campus Housing

Prohibited Materials and Appliances in All Campus Housing

Personal air conditioners, sun lamps, and heaters may not be used due to safety concerns. Substances that could cause a fire, such as paints and chemicals, may not be stored in campus housing. Students may not store or repair motor vehicles in their residences. Flammable liquids such as gasoline, kerosene, and other fuel products may not be kept in campus housing. Fireworks and/or firecrackers are not allowed on the campus. The burning of candles, incense, etc., is also prohibited in all campus housing.

Additional Policies for Appliances in Residence Halls

Cooking equipment such as hot plates, toasters, electric fry pans, microwaves, and coffee pots (unless the coffee maker is equipped with an automatic shut-off or is a single-cup maker with no hot plate) is not permitted and will be removed from residence halls.

Smoking/Tobacco Use

HPU is a smoke-free campus. Smoking (including vaping, the use of electronic cigarettes (e-cigarettes), etc.) is prohibited on campus. The possession of smoking, vaping, and electronic cigarette products is also prohibited on campus. The use of smokeless tobacco is prohibited inside all University buildings and within 25 feet of any building entrance.

Smoke Alarms

A fine of \$100 will be charged for vandalism, tampering, or removal of smoke alarms. Additional disciplinary sanctions may also be issued up to and including expulsion.
